Therefore, at this time, Borough will stay with Mallie. Treasurer also stated that the 2022 UC rates would remain the same as in 2021.

 Application/new LOI needs to be in by mid January. Funding request is for 1 million dollars.

Council member Ewing made motion to accept this final budget, Council member Frost second, all in favor, motion passed.
