**NOTICE IS HEREBY GIVEN** that Modena Borough Council, Chester County, Pennsylvania, at a public meeting scheduled for April 3, 2023, at 7:00 p.m., to be held at Modena Borough Hall, 5 Woodland Avenue, Modena, PA, will consider and may enact an ordinance amending Ordinance No. 152 of 2013, Stormwater Management Ordinance, a caption and summary of which follows: **AN ORDINANCE AMENDING ORDINANCE NO. 152 OF 2013, STORMWATER MANAGEMENT ORDINANCE, OF THE BOROUGH OF MODENA, CHESTER COUNTY, BY DELETING AND REPLACING ORDINANCE NO. 152 OF 2013, STORMWATER MANAGEMENT ORDINANCE, IN ITS ENTIRETY.** The ordinance comprehensively repeals and replaces the entire Borough of Modena Stormwater Management Ordinance. The ordinance further provides that: all ordinances or parts of ordinances conflicting with any provisions of the ordinance are hereby repealed insofar as the same affects the ordinance; if any sentence, clause, section or part of the ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections

or parts hereof; and the ordinance shall as provided by law. The complete text of the ordinance can be examined at the Chester County Law Library, 201 West Market Street, West Chester, Pennsylvania or at Borough Hall at the above address during regular business hours. Copies of the ordinance may be obtained at a charge not greater than the cost thereof. If you are a person with a disability wishing to attend the aforementioned meeting and require auxiliary aid, service or other accommodation to observe or participate in the proceedings, please contact the Borough secretary to discuss how your needs may best be accommodated.




